### Chancellor Launches Saudi Book


On Friday 27 September at the Parramatta FutureCampus, the Chancellor Dr John Watkins launched the book Higher Education in Saudi Arabia: Achievements, Challenges and Opportunities. The book, available in hard cover and on-line, has been published by Springer in the Netherlands, and was edited by Professor Larry Smith from the UNE Business School and Professor Abdulrahman Abouammoh from the Centre for Higher Education Research and Studies (CHERS) in the Ministry of Higher Education in Saudi Arabia.

Among the guests at the launch were: the Saudi Cultural Attaché to Australia, Dr Abdulaziz Bin-Taleb; the Director of CHERS, Dr Abdulhalem Mazi; the Pro-Vice Chancellor Educational Innovation and International, Dr Michael Crock; President of the Saudi Student Club in Armidale, Abdullah Alazani; the Managing Director of UNE Partnerships Richard Doyle; and several UNE staff and Saudi students. The book launch was also linked by video-conference to Saudi students and members of staff in Armidale.

This is the only English language book to comprehensively and independently detail and analyse the Higher Education system in Saudi Arabia. It addresses its history, aspirations, structure, governance, strategic planning approaches, teaching and learning culture, research productivity, quality assurance processes (including accreditation), progress towards internationalisation, initiatives to improve access for women, and the emergence of a private university sector. The Foreword for the book was written by the Saudi Minister for Higher Education, His Excellency Dr Kalid Al Ankari.

Each of the chapters in the book has been written by a team of authors that includes one or more Saudi academics or system administrators and an author of international standing from a non-Saudi university. The 17 Saudi authors include Dr Mohammed Al-Ohali (Deputy Minister for Educational Affairs), Professor Mohammad Al-Shehri (Vice President and Professor of Surgery, King Saud University), Professor Fatima Jamjoom (Vice President for Female Students, King Saud University), and Professor Waleed Al-Dali (Supervisor, Directorate of Private Higher Education, Ministry of Higher Education). The 15 international authors come from seven countries, and include Professor Philip Altbach (Director, Centre for International Higher Education, Boston College), Professor Phil Cardew (Pro Vice-Chancellor [Academic], London South Bank University), Professor Ian Newbould (President, Richmond American University) and Professor Kwong Lee Dow OAM (formerly Vice Chancellor of the University of Ballarat and Deputy Vice Chancellor, University of Melbourne).

The book has already sold over 500 copies, and negotiations are currently taking place for its translation into Arabic and German.





### E-Learning Workshop

Professor Alison Sheridan and Ms Kay Hempsall attended the Workshop on e-learning in Economics and Business Studies at the Open University of Catalonia (UOC), Barcelona, Spain on 25 October 2013. The workshop opened with an inspirational keynote address by Professor Albert Sangrà, Director of eLearn at UOC, who spoke of the importance of using online tools and pedagogies in new ways rather than focusing on using new tools to continue traditional teaching and learning methodologies. Many of the parallel sessions were in Spanish but fortunately for Kay and Alison there were a number of papers presented in English! Alison's paper focused on the importance of teamwork in transitioning from a traditional distance learning model to a fully online model which was co-authored by Sue Whale and Valerie Dalton, while Kay presented a paper co-authored with Valerie Dalton, Bligh Grant and Theresa Smith-Ruig on the challenges associated with developing virtuous character traits in business students in a fully online model.

During the four days preceding the workshop both Kay and Alison were busy working with our colleagues in the School of Economics and Business Studies at UOC: Professor Àngels Fitó Bertran (Director), Dr Enric Serradell López (Senior Lecturer) and Dr Ramon Ribera Fumaz (Lecturer). Alison worked on progressing the IMBASE project while Kay focused on developing a joint grant proposal to develop an online interactive space which business students can use to develop their leadership capabilities with a strong focus on developing virtuous character traits to support ethical and sustainable business practices in the long term.

Both Alison and Kay were the recipients of the warm and generous hospitality of our UOC colleges, and this visit has further consolidated the relationship between UNE Business School and UOC Economics and Business Studies which evolved from the DeHUB initiative.

### **Engagement With Chinese Partners**



Dr Bligh Grant Lecturer

As part of the School's arrangements with its China partners, Bligh visited two Universities in China in October. First, Henan Agricultural University (HAU) located in the city Zhengzhou, approximately 1000 km North West of Shanghai. Bligh taught Business Management, International Business and Value Chains here as well as discussing inter-university arrangements and scoping research opportunities with Faculty members. He also visited Henan Museum, a major national museum documenting eight thousand years of Chinese history, and Shaolin Temple, the Buddhist retreat that is home to the fable of 'King Monkey' and formed the backdrop of the television series 'Monkey Magic'.

Second, Harbin Engineering University (HEU) in the far North. HEU is a 'Top 211' Chinese university and was originally a PLA (People's Liberation Army) institution that now specializes in shipbuilding and nuclear science, as well as having the usual suite of faculties and schools. Bligh lectured in IPE (International Political Economy) and International Business, and gave a lecture on public value to members of the Economics Faculty and on the GFC to the English Language Association students. He also briefly toured beautiful Harbin City, learning that it was originally constructed by the Russians early in the twentieth century

then liberated from Japanese occupation by the Soviet Army in 1944.

Both institutions assigned Bligh a guide from their respective international offices - Zhou Kaiyan at HAU and Tongli Niu at HEU - who acted as in-class translators as well as showing him around their respective cities and introducing him to some excellent examples of local cuisine. Bligh said: 'It was one of the most interesting work trips ever; certainly on a par with hanging out in Faislabad, Pakistan, with Professor Oscar Cacho in 1996'.

Bligh would like to thank Dr Lou Conway, Dr Tony Ramsay and Dr Emilio Morales for providing PPTs from their units for his use teaching in China.

### Marketing: A Snapshot





This would be a good deadline for revisions to unit materials as well, especially if you are planning to be on leave during December and / or January. I realise this is only one month away, but as always the timing can be flexible, and should be discussed with your EDC or Admin contact. Trimester 1 units will be released to students on 10 February 2014.

A reminder that Assessment tasks set up in Moodle will reflect the information provided on the Course and Unit Catalogue (CAUC). This includes assessment type, weighting, length, whether compulsory, and if the task requires a passing grade in order to pass the unit. This information should be included on Unit Amendment forms in order to be uploaded to CAUC.

Trimester 3 undergraduate units have been reviewed by the Courseware Enhancement project and apart from Learning Outcomes and Graduate Attributes (which are the most commonly highlighted issues), copyright concerns are appearing in a lot of reviews. Copyright issues extend

to powerpoints where you either record them (through Camtasia) or upload them to the Moodle site. When you develop powerpoints, please try to use images from photo databases where a creative commons licence applies http://www.pics4learning.com/; (eg http://office.microsoft.com/en-au/ http://www.morguefile. images/; com/; or http://www.flickr.com/) and cite a reference for the image. I will be talking to coordinators about this as it arises in reviews, and there will be central assistance for locating alternate images, or sourcing references for any those already in use.

We are hoping to hold a Teaching and Learning Showcase in November and will send details on this once it is finalised.

Ms Valle de Souza attended the ICES Annual Science Conference 2013, which was held in Reykjavik, Iceland, at the end of September.

She presented a work entitled "The Effect of Environmental Variables on Catch of Banana Prawns in the Australian Northern Prawn Fishery" and attended to talks and discussion sessions in the area of climate change, which included discussions such as projecting distribution and abundance changes in marine resources, estimating climate and ecosystem changes and fisheries management strategies in the light of these changes. Discussions were interesting and enlightening.

The International Council for the Exploration of the Sea (ICES) has a network of scientific, advisory, and governance members, which promoted productive discussions from all relevant aspects of fisheries management and adaptation of policy to climate change.



# Office 2010 tips and tricks:


#### Customize the Ribbon

Office 2010 lets you rearrange the Ribbon the way you want by clicking the File tab selecting Options, and then Customize Ribbon. In the righthand column, you can create a new tab or a new group on an existing tab, remove or rearrange items already on the Ribbon by selecting them in the right-hand column, or select items that you want to add from the list on the left. Note: A button at the lower right lets you export your customizations to other Office setups.



#### Make Your Own Quick Steps in Outlook

Outlook's Quick Steps feature lets you create one-click (or one-keystroke) e-mail actions. For example, moving a message to a folder you use for archiving messages. You create a new Quick Step by going to Outlook's Home tab, then clicking Quick Steps, Create New. There you'll assign a name, shortcut key, and tooltip for your Quick Step, then use the drop down menus to select one or more actions. When you're done, your new Quick Step will be available from the gallery of Quick Steps in the Home tab, or via a shortcut key.




### **Teaching Awards**
